Welcome to what will hopefully be a long and successful association with Torquay Boys' Grammar School.

The TBGS Charitable Trust is dedicated to raising funds to support both the day-to-day operations of the School and capital developments, many of which require some form of match funding in order to attract grants from public and private organisations. Examples where the Trust has given support over the years range from the building of the Cavanna Centenary Hall, for which we raised over £600k, to donations of £25k to provide a new minibus for the School and £120k for a much-needed re-fit of our Science Laboratories.

In 2019 The Trust supported the school by paying for an upgrade to the old IT servers in addition to contributing to a whole raft of curriculum resources, including an upgrade to boilers and refurbished toilets, and an overhaul of the fire protection system, along with a grant which helped towards improving the SEND provision at the school.

Now that school life has returned to normal following the pandemic (which cost the school in excess of £50k in lost lettings income) there are a number of projects requiring attention and we are specifically supporting the school's endeavours to improve the Physical Education facilities through the Activ8 campaign; this has already resulted in the re-surfacing of the astroturf facility next to the top playing fields.

At a time when the funding of schools continues to be inadequate (you will know only too well that teaching unions have taken industrial action regarding the lack of funding for schools as well as the pay and conditions for teachers) the need to have an alternative source of funds to support the many rich and varied activities in the school, whether academic, sporting or cultural, becomes evermore important.

The Trust accounts are held completely independently of the School, are audited annually and are submitted to both the Charity Commissioners and to Companies House. The Trustees & Directors comprise of Past and Present Parents, Old Boys, Friends of the School and Staff.

As Chair of the Trust and as Headteacher our appeal is to ask you to consider helping us financially to achieve our objectives. To be specific, we would ask you to contemplate making a regular donation by bank standing order to the Trust. This can be completed directly with your bank online or by completing the enclosed form. Further, if you complete the enclosed **Gift Aid form**, the Trust is able to claim a tax refund at the rate of 25 pence for every £1 you donated. We would stress that all contributions are purely voluntary and are treated as strictly confidential. Indeed, no member of staff at the school, including the Headteacher, is aware of the identity of those who contribute as it is of paramount importance that no student is treated differently because of their parents' ability or willingness to contribute.
